A. Call to Order

John Ladd called the meeting to order at 7:33 a.m.

B. Introductions

No introductions were necessary.

C. Call to the Public.

There was no call from the public.

E. Review and Approval of Meeting Minutes

1. Regular Meeting, October 17, 2018

Motion: David Greenberg moved to approve the regular meeting minutes of October 17, 2018.

2. Special Telephonic Meeting November 19, 2018

F. Committee and Other Reports

1. Upper San Pedro Partnership (USPP): There is a meeting December 19, 2018, 9 a.m.-12 p.m. at the Council Chambers at City Hall. They will be discussing their science summit planning. The Technical Committee of the USPP seems to be the most valuable facet of the group.

2. NRCS: Don Decker reported there is a schedule for the EQIP program for fiscal year 2019. At this point there is just one cycle for 2019. At Don's office level they are to have their producers eligible, ranked and assessed, with the proposal written up, by March 15, 2019. The area office will pre-approve proposals March 22. All funding has to be in place by June 1, 2019.

3. USFS: No one present to report.

4. BLM: No one present to report.

5. AZGFD: Sarah Gandaria reported the next local Habitat Partnership Committee (HPC) meetings will be in Spring 2019. Brad Fulk leads the Sierra Vista Chapter. The next deadline to apply for HPC funds is September 1, 2019. For those people who applied for HPC funds in September 2018, they will be notified if they were funded following the funding meeting in

Landowner Relations Program (LRP) currently has funding available for projects through our access program (which provides public access to private lands.) There is no deadline, but cooperators are encouraged to reach out prior to July 1st. People interested in the program can call Matt Walton at (520) 388-4468 or myself at (520) 388-4471. LRP will also have funding becoming available for habitat improvement projects (projects that will mutually benefit wildlife and production) in July 2019. This is a cost-share program for projects smaller than \$20,000. Again, there is no deadline, but people interested in the program are encouraged to contact me prior to July 1, as funds will be allocated on a first come first serve basis. <https://www.azgfd.com/Wildlife/LandOwners/>

Partners for Fish and Wildlife (US Fish and Wildlife) and Arizona Game and Fish also have funding available for smaller projects on private land only, that will mutually benefit wildlife and production. There is no deadline to apply, but funds will be allocated on a first come first serve basis. 6. The Arizona Rangeland Conservation Partnership: This will be removed from the agenda until further notice.

7. Cochise Conservation and Recharge Network (CCRN): John Ladd reported there was a very productive meeting last month with the current projects being reviewed and studies on them being reported.

8. Fort Huachuca Sentinel Landscape Restoration Partnership (SLRP): Lucinda Earven attended an October meeting led by Scott Feldhausen--BLM that was quite good. In their strategic plan review and discussion they talked about open space, working lands, endangered species, hazardous fuels and wildfires. There is supposed to be a final plan in December approved by the NRCS but Don Decker has not heard anything about it to date. They said they thought it was more efficient to hire a leader for the steering committee, rather than using a volunteer. They want to make more outreach to private land owners. NEPA has been done—shovel ready—for some projects and NRCS Easement Coordinator, Scott Morton is on board. They reported 18 million from the Farm Bill has been appropriated. They presented a production they had produced to show what SLRP has done in other parts of the country. Grizzly Creek Productions was supposed to be filming in November here to highlight the southwest. Lucinda contacted John Ladd about that because they needed ranchers to interview but John never heard from them. There was no report on the scheduling of another meeting.
