#### D. Jackie Thomas—Arizona State Land Department with Updates

Jackie Thomas reviewed the Arizona Gift Clause, which only applies to State funds In the future, in order for the District to contribute funds to such organizations as FFA, NRCWAY, etc. it may be the District will have to have a contractual agreement with said organization, rather than making a direct contribution as the District has done in the past. Jackie has been working on a template along those lines. This issue has never before been addressed by ASLD. Jackie is having a meeting with the ASLD Commissioner today and will get information to the state NRCDs just as soon as possible.

Jim Lindsey outlined for Jackie how the District FFA donations have been used by Tombstone High School.

John Ladd asked how dues to AACD figure into the Gift Clause. Jackie didn't have a specific answer for this question, however, she has been working with Deborrah Smith-AACD on this issue.

At the January AACD Winter Conference Jackie will be presenting how the Districts should be submitting budgets to ASLD. Jackie will also provide guidelines for the Districts to follow on how State funds may be spent.

Jackie confirmed that State funds may be used to reimburse supervisors for travel, etc. when working for the District.
