#### **REGULAR MEETING MINUTES**

Wednesday, August 21, 2019

#### A. Call to Order

John Ladd called the meeting to order at 9:32 a.m.

#### **B.** Introductions

Introductions were made around the room.

#### C. Call to the Public

Holly Richter introduced herself as a relatively new HNRCD cooperator as well as her role with The Nature Conservancy. Hans J. Huth—Senior Hydrologist, ADEQ introduced himself.

### D. Review and Approval of Meeting Minutes

1. Regular Meeting, July 17, 2019

*Motion:* Mike Hayhurst moved to approve the regular meeting minutes of July 17, 2019.

Second: Lucinda Earven seconded the motion.

*Vote:* Carried unanimously.

### E. Committee and Other Reports

- 1. USPP: Lucinda Earven reported the last meeting was cancelled. Holly Richter reported the organization is going through some major overhauls.
- 2. NRCS: Dusty Glidewell reported the annual Coordinated Resource Management Meeting for Cochise County Ranches was today in Willcox. This meeting allows for all the various NRCS agency field personnel who are working with ranchers on rangeland in the area to meet and discuss ranch conservation planning they are working on together.
  - 3. USFS: No one present to report.
  - 4. BLM: No one present to report.
- **5. AZGFD:** Sarah Gandaria gave a brief report, including the fact that Sierra Vista/Douglas will not be having an HPC meeting. She said there are still some funds available. Contact Sarah for more information on HPC meetings.
- **6. CCRN:** Holly Richter dispersed two fliers on the CCRN: Cochise Conservation & Recharge Network—Supporting the San Pedro River and Local Communities and CCRN Interim Findings from the Hydrologic Monitoring Program. Jack Ladd asked the status of the Bisbee effluent. It's being "talked about."

**7. SLRP:** The last meeting was cancelled. Sarah Gandaria reported the drafts for strategies have been submitted for each group. The next meeting is scheduled for October, 2019. Willie Sommers is still the Chairman.

### F. District Financial Reports

Motion: Lucinda Earven moved to authorize payment of items 1-4 on the Payment Schedule.

Second: Mike Hayhurst seconded the motion.

*Vote:* Carried unanimously.

The approved financial reports will be submitted for audit.

Jim Lindsey reported the District is required by Arizona State Land Department to have four checking accounts: #1) account for ASLD District funds, #2) account for Education Center ASLD funds, #3) account for District funds, i.e. donations, cooperator dues, etc., #4) account for Education Center funds, i.e., donations, etc. Jim said the ASLD is going to be very specific as to what can be paid with ASLD funds.

ASLD is going to begin doing direct deposits rather than mailing checks.

*Motion:* Jim Lindsey moved to open three checking accounts required by ASLD to meet their

financial requirements. Two accounts will be for ASLD monies and one account will "go with" the existing account to be for District monies separate from ASLD funds. The bank signature card for each account will include: Jim Lindsey—Treasurer, John Ladd—Chairman, Lucinda Earven—Vice Chairwoman, David Greenberg—Supervisor, Mike

Hayhurst—Supervisor.

Second: David Greenberg seconded the motion.

Vote: Carried unanimously.

Discussion: A discussion ensued as to how to divide the District monies among the two District

accounts. It was agreed to take \$2,500 from the HNRCD savings account for the new Ed Center account and to leave the \$2,500 in the Horseshoe Draw account in place to be spent on Horseshoe Draw monitoring. Once the \$2,500 in the Horseshoe Draw account has been spent that account will be closed. The Horseshoe Draw money was HNRCD

money to begin with. It was "seed money" to begin the project.

HNRCD will be responsible for the additional bank fees for the "extra" accounts even

though this is required by ASLD.

Motion: Jim Lindsey moved to close the District savings account and move all but \$2,500 to the

District general account. The \$2,500 will be to open the Ed Center general account.

Second: Mike Havhurst seconded the motion.

Vote: Carried unanimously.

### **G. Old Business**

1. Society for Range Management Winter Meeting, January 22-24, 2020: Dusty Glidewell reported she did not yet know what the registration fee will be. The meeting will be at Rancho des los Caballeros in Wickenburg, AZ.

#### 2. Soils Workshop Plans

- ✓ Date and time agreed on: October 5, 2019, 9:00 a.m.—12:00 p.m.
- ✓ HNRCD will provide water, no refreshments or lunch.
- ✓ Amber Ford—THS will be in contact with Jim Lindsey on procuring the high school for the event. Amber said the FFA students do want to be involved in the workshop.
  - Mike Hayhurst volunteered to make sure the school is available and the District can use it.
- ✓ John Ladd said Kim McReynolds has committed to the project. John has the name of an NRCS soils expert in New Mexico that might come. Dusty Glidewell will send John the contact information of an Arizona NRCS soils expert.
- ✓ Steve Boice said the Cochise College garden expert will come depending on the date. Steve will let her know the date and time today.
- ✓ Jim Lindsey contacted the Sierra Vista Farmers' Market but they have yet to get back with him.

- ✓ Nancy Neumann said she will contact the Bisbee Farmers' Market.
- ✓ Lucinda Earven will produce a flier and Kathy Morris will disperse it to everyone connected with the HNRCD. Lucinda will contact the Sierra Vista Herald.
- ✓ Dusty Glidewell said Don Decker will be able to attend.
- ✓ Sarah Gandaria said she will be able to attend.
- Dusty Glidewell will send contact information to Kathy Morris for the Cochise County Fair personnel.
- ✓ Whitewater Draw NRCD, Willcox NRCD, Santa Cruz NRCD, and San Pedro NRCD will be sent fliers and asked to invite their cooperators.
- **3. Possibility of HNRCD Purchasing Equipment:** Mike Hayhurst reported he was quite enthusiastic on this possibility until he spoke with people that had tried it. He heard stories of people getting injured on district equipment, district equipment breaking down and the responsibility of repairs being in question, and insurance being a big factor. The more he learned the more he was certain it is not a good idea for the District to buy any kind of equipment for cooperator use or loan.

Mike was most interested in the District purchasing a drone after attending the HNRCD/WWDNRCD drone workshop last winter. But even with a drone the same kinds of problems could exist. John Ladd said several producers are looking into purchasing a drone on their own—not going through any specific NRCD. It was pointed out there are several people/organizations in business who fly drones for various projects and concerns.

It was a unanimous agreement the HNRCD should not buy a drone or any other equipment.

That email was forwarded to Kim McReynolds—NRCWAY, so they are all in touch with one another.
- **4. Paid Cooperator Dues Report:** Kathy Morris reported there are only seven members who have not paid 2019 dues. A reminder letter will be sent to those people.
