A. Call to Order

John Ladd called the meeting to order at 9:31 a.m.

B. Introductions

Introductions were made around the room.

C. Call to the Public: Tricia Gerrodette requested that when the HNRCD Board of Supervisors approve any letter to be sent to anyone representing the District that the letter be attached to the Minutes of the meeting approving said letter. Kathy Morris will check with ASLD to see if this is a requirement.

Tricia Gerrodette requested that when a vote is taken by the HNRCD Board of Supervisors if there is a "nay" vote the Minutes of the meeting should state who voted "no." Kathy Morris will check with ASLD to see if this is a requirement.

Jo Ann Gasper—Keep Our Wells expressed her organization's concern over the substantial amount of mesquite trees and how much water such overgrowth consumes.

E. Agency and Committee Reports

1. USPP: Nancy Neumann and David Greenberg attended the last meeting. USPP and UA Cooperative Extension Water Wise have teamed up to deliver grants for saving money on water costs. Such a grant went to the City of Tombstone for \$2,000. See their website, <u>https://uppersanpedropartnership.org</u> for more information on these grants.

2. NRCS: Don Decker reported he has been working with Deborrah Smith—AACD on the HNRCD / WWDNRCD technical service provider position grant for the Douglas Field Office. The position would work within both Districts to carry out needed conservation activities. The Districts may know by April, 2020 if the grant is awarded to them. If the grant is awarded Don is hopeful the individual hired will be

able to make initial visits to small land owners with conservation needs, as well as assisting on EQIP projects.

3. United States Forest Service (USFS): No one present to report.

4. BLM: Eric Baker reported they are currently in the implementation phase of the SPRNCA RMP. Eric has been working individually with the land owners of the four grazing allotment holders currently on SPRNCA. They plan to complete land health evaluations on the four allotments this year.

BLM has done a lot of monitoring with their Assessment, Inventory, and Monitoring (AIM) Strategy, which is more standardized monitoring. With the AIM Strategy they are able to collect much more data that is going into a national data base. Arizona is eight to ten years behind the rest of the west with collected data.

The BLM drone program was squashed. Nationwide BLM is not able to fly drones for any natural resource purposes or collect data with the use of drones. The manufacturing of the software is in China. There is some issue with individual privacy, but national privacy is a concern as well as a trade issue.

5. AZGFD: Brad Fulk reported they have filled two of their employee vacant districts. Wildlife surveys went really well. Deer numbers are way up. Antelope numbers are trending up. AZGFD has been busy this year with some big law enforcement cases. The next HPC meeting will be March 17, 2020, 1:30-4:30 p.m. at the Sierra Vista Ranger District Office. The 1/4 mile rule applies to any form of archery as well as rifle use when hunting.

6. CCRN: John Ladd reported the next meeting will be March 14, 2020. HNRCD submitted a letter of support for the Bella Vista Project to the State Conservation Engineer, the Arizona State Conservationist, the USDA, NRCS, Office of the Chief, and the U.S. Under Secretary of Agriculture.

7. SLRP: Mike Hayhurst and Joy Banks attended. No specific decisions were made or action taken, but two presentations were made, one using satellite images to locate specific stands of vegetation, and one by Hans Huth—ADEQ. Brad Fulk reported the sub groups have an approved plan in place and the main group has an approved plan in place. Now the sub groups are going to begin to prioritize two to three projects to begin working on, pending availability of funding.

HNRCD's support of SLRP is more meaningful now that SLRP's mitten has been enlarged, including more of the District and grassland restoration is a priority of SLRP.

The next SLRP meeting is April 3, 2020, 1:00 p.m., at the Sierra Vista Library.

8. Arizona Department of Environmental Quality (ADEQ): Hans Huth reported ADEQ has over \$400,000 available for projects. The feedback he has received from people is a need for help on State land projects, specifically those requiring archeological assessments. Drone surveys would be very helpful to establish baseline conditions and determine what needs to be done, where. Engineered prescriptions would be helpful, particularly for soil conservation.

2. Arizona Association of Conservation Districts Winter Meeting January 28-29, 2020,

Phoenix, AZ: Jim Lindsey attended the first day. It was well attended, with over 20 districts represented. A highlight presented was that for every \$1.00 NRCDs receive from the State the districts were able to raise an additional \$93.00 from other sources towards implementing conservation practices. There was a lot of discussion regarding the local working group meetings that Keisha Tatem—NRCS wants the districts to hold every year. For the majority of districts, their priorities don't change, so the question was raised why these meetings were necessary every year. These meetings are supposed to consist of all the agencies districts work with, i.e. BLM, etc. HNRCD has representatives from the agencies at regular meetings so did not hold a local working group last year. However, Keisha Tatem still wants this done and along with ASLD will be coming out with some new forms that will need to be addressed by the District. It was highly recommended the Board Clerk attend this summer's AACD meeting. State funding was discussed and again it was pointed out the money that is appropriated for the districts is enough funding to just barely maintain administrative costs, so no State funds are available for "on the ground" projects. AACD is definitely working hard for the local districts and a big thank you goes out to Frank Krentz and Deborrah Smith.

3. Arizona Gift Clause: The District received from ASLD a draft MOA which will need to be used for donations to such programs as the Tombstone High School FFA program.
