A. Call to Order

John Ladd called the meeting to order at 8:07 a.m.

B. Introductions

People identified themselves as they logged onto the call.

C. Call to the Public: Tricia Gerrodette said she wanted to inform the HNRCD Supervisors and Hans Huth—ADEQ that there have been recent photos taken of cattle damage to the SPRNCA to the north of the Hereford Bridge, on the west side of the river. Tricia said when the flood waters come "an awful lot of erosion" will occur so there will be silt carried downstream. She said she would like to make sure Eric Baker—BLM knows about it. The question was asked: who took the photographs—was it an individual or an organization? Tricia disclosed that a friend of hers took the photos but the photographer wanted to remain anonymous.

The District comment was: this is a BLM issue.

- **1. USPP:** Lucinda Earven reported the last meeting was cancelled. The next meeting is scheduled for August 12, 2020.
- **2. NRCS:** Don Decker reported EQIP applications are due for ranking today. By May 22, 2020 the top scoring applicants will be preapproved. All contracts are to be funded by June 22, 2020. There are seven applicants from the Hereford District and they are all rangeland resource related.
 - 3. USFS: No one present to report.
 - **4. BLM:** No one present to report.

Mike Hayhurst brought up that BLM is involved in a lawsuit with the Center for Biological Diversity and Western Watershed over the four existing cattle allotments on SPRNCA. Mike would like the District to respond to this issue with a support letter of BLM's RMP.

- **5. AZGFD:** No one present to report.
- **6. CCRN:** There is a scheduled meeting May 20, 2020 to review benefits of existing projects and to review the status of proposed projects.
 - 7. SLRP: Nothing to report.
- **8. ADEQ:** Hans Huth reported the grassland subcommittee of SLRP had a meeting a couple of weeks ago to identify the priority projects for rangeland, focusing on water projects—the Babocamari River in particular. Hans will be presenting two projects today to the Water Quality Division Director of ADEQ; one a fencing project and the other a rangeland restoration project.

- 1. Wildlife Attractors Workshop: The workshop is still postponed, with no new date yet set.
- **2. HNRCD October Meeting Date Change:** Still tabled. Kathy Morris will keep checking and trying to contact the room reservationist at the Sierra Vista County Complex.

H. New Business

1. Sharma Torrens—AACD: Sharma reported the AACD annual conference scheduled for July 7-9, 2020 has been cancelled until next year due to COVID 19. AACD, on behalf of the NRCDs, is going to be seeking the NRCS Regional Conservation Partnership grant. The focus will be on soil health for this region. It's going to be basically education and outreach to producers, to encourage them to implement the conservation stewardship program and/or NRCS practices that revolve around soil health. The first focus will be in the Wilcox area, then all of Cochise County. An essential goal is water conservation. Healthy soil equals longer and better water retention.

2. Nomination for Appointment of Two Supervisors:

Nomination: Mike Hayhurst nominated John Ladd to continue and Steve Boice to fill David

Greenberg's post who is retiring the end of May, 2020 to the two appointed supervisor

seats.

Second: Jim Lindsey seconded the nomination.

Vote: Carried unanimously.

Discussion: Jim Lindsey mentioned the email from Jackie Thomas—ASLD stating one signature will

suffice on the ASLD candidate nomination form as long as the meeting minutes are

attached.

- 3. Comment Letter—Critical Habitat for the Northern Mexican Gartersnake and the Narrow-headed Gartersnake: The District officially commented on this in 2013. According to the current Federal Register if comments were made earlier there is no need to comment again.
- **4. 2020 Annual Plan of Work—Due June 20, 2020:** John Ladd and Jim Lindsey will meet with Kathy Morris to complete the computer work. Mike Hayhurst and Steve Boice will each "take a turn" with John or Jim and Kathy to familiarize them with the process.

Jim Lindsey is working with Deborah Smith—AACD on the District and District Education Center financial reports/requests for ASLD.

- 1. Tombstone High School Ag Program: Nothing to report. No one has any knowledge when/if school will resume.
