### A. Call to Order

John Ladd called the meeting to order at 8:16 a.m.

### B. Introductions

People identified themselves as they logged onto the call.

**C. Call to the Public:** Tricia Gerrodette asked what projects were selected as the top four projects by SLRP.

### D. Review and Approval of Meeting Minutes

#### 1. Regular Meeting June 17, 2020

**Motion:** Steve Boice moved to approve the regular meeting minutes of June 17, 2020 as written.

**Second:** Lucinda Earven seconded the motion.

**Vote:** Carried unanimously.

### E. Agency and Committee Reports

1. **USPP:** Lucinda Earven said there was nothing to report.

6. **CCRN:** John Ladd reported CCRN had a Zoom meeting last month that was an overview of all their projects.
7. **SLRP:** Mike Hayhurst had nothing to report. He didn't have an answer to Tricia Gerrodette's question in *Call to the Public* but he said SLRP does have online information available.

*Second:* Jim Lindsey seconded the motion.  
*Vote:* Carried unanimously.

## **G. Old Business**

**1. Wildlife Attractors Workshop:** Steve Boice reported there are no updates. He has spoken with everyone who was originally involved and they are still willing to participate but everyone is still “on hold.”

Sharma Torrens—AACD offered help from AACD if the District is interested in doing an online workshop.

**2. HNRCD October Meeting Date Change:** Kathy Morris reported the Cochise County Complex building is still closed to the public, as well as the public library and the public meeting room at Sulphur Springs Valley Electric Cooperative, Inc.

Mike Hayhurst suggested we have an in-person outside meeting somewhere. Veterans’ Park in Sierra Vista was suggested. This may be a possibility for the August meeting.

### **3. Arizona Land & Water Trust Support Letter**

*Motion:* Steve Boice moved to approve and send the ALWT support letter as written.  
*Second:* Jim Lindsey seconded the motion.  
*Vote:* Carried unanimously.

## **H. New Business**

### **1. Approval of District Annual Report**

*Motion:* Jim Lindsey moved to approve and submit the HNRCD Annual Report to ASLD.  
*Second:* Steve Boice seconded the motion.  
*Vote:* Carried unanimously.

### **2. Approval of Education Center Annual Report**

*Motion:* Jim Lindsey moved to approve and submit the HNRCD Education Center Annual Report to ASLD.  
*Second:* Steve Boice seconded the motion.  
*Vote:* Carried unanimously.

**3. Regional Conservation Partnership Program (RCPP) Letter of Support:** Sharma Torrens reported this is the same program as the RCPP support letter approved in Old Business, #3; however, AACD, working with NRCS, will be focusing on soil health. They are focusing on Cochise and Santa Cruz Counties (ultimately hoping to go statewide) and are looking for support from all the NRCDs in those two counties. AACD is seeking a five-year grant that is designed on educating farmers and ranchers on the importance of soil health and how to implement healthy soil practices. This program will eventually lead to water conservation because healthy soil equals “spongy” soil which holds water better and longer.

Sharma said what AACD is asking for from the NRCDs is a letter of commitment to help market any educational workshops on the subject of soil health to district producers (cooperators). If the NRCDs want to be involved in any workshops that would be fine, but AACD is just asking for “time.”

*Motion:* Steve Boice moved the HNRCD write a letter of commitment to AACD on the RCPP Soil Health Grant.  
*Second:* Jim Lindsey seconded the motion.



**Vote:** Carried unanimously.  
**Discussion:** Steve Boice asked when the letter of commitment was due. Sharma said the grant will be opening up the end of July at which time there will be a letter of commitment template. AACD will get the template to the board clerks in early August, 2020.

#### **4. Malwarebytes for HNRCD Computer:**

**Motion:** Jim Lindsey moved to approve the use of Malwarebytes on the HNRCD laptop for another year at the rate of \$43.21.  
**Second:** Steve Boice seconded the motion.  
**Vote:** Carried unanimously.  
**Discussion:** The question was asked "what other protection do we have on our computer" and the answer was, "only the available free downloads plus *Microsoft Office 10* protection."

#### **5. American Stewards of Liberty Dues:**

**Motion:** Jim Lindsey moved to renew the District membership with ASL for \$250.00.  
**Second:** Lucinda Earven seconded the motion.  
**Vote:** Carried unanimously.  
**Discussion:** Jim Lindsey stated the ASL membership increments from their invoice and there was unanimous agreement to "up" the District payment from last year.

**6. HNRCD "Old" Dell Computer:** Kathy Morris explained the computer technician who had helped her with the purchase and installation of the new HNRCD laptop had worked five hours (his rate being \$20/hour) and that he had not been paid. He would like to trade his services for the HNRCD's old Dell laptop. Kathy had researched the approximate worth of the Dell and said it seemed to be worth around \$100-\$130, but it does have *Windows 7* installed, which is no longer supported by Microsoft.

**Motion:** Mike Hayhurst moved to trade the Dell laptop for Jim Barba's past work.  
**Second:** Jim Lindsey seconded the motion.  
**Vote:** Carried unanimously.  
**Discussion:** Jim Lindsey asked that an invoice be written to represent the trade. Jim also wanted to make sure all HNRCD material on the Dell laptop was deleted. Jim Barba had previously said he would assist Kathy Morris in so doing.

### **I. Education Programs**

**1. Tombstone High School Ag Program:** Nothing to report. Sharma Torrens said there was some funding available from the Legacy Foundation and she wondered if the HNRCD wanted to pursue that avenue in regard to purchasing a building for the FFA students. Jim Lindsey has been trying to get in touch with the school superintendent to seek his input on that subject but has been unable to reach him. Sharma offered AACD support and help.

**2. Supervisor Contact San Pedro Spirits 4-H Group:** Steve Boice reported the 4-H group is in "standstill" like everyone else.

*Vote:* Carried unanimously.


