Small Acreage Land Owner Invasive Species **District Program Technical Support**

Summary

A trustee for land that was transferring into new ownership contacted the District. The new owners Importance were unfamiliar with range property. The trustee contacted the District Board for guidance on treatment and potential funding to combat an invasive plant species. While the District was unable to provide funds, the Board coordinated efforts between the trustee and the local NRCS field office. The District Soil Conservationist conducted a site visit of the property, provided an analysis of the vegetation condition, and a report to the trustee of best management practices for future land planning by the new owners.

This was important for the District's exposure to a potential new cooperator and ability to provide technical support and contact resources for the landowner. It is important to expose the HNRCD name to the public as much as possible and in multiple venues for purposes of encouraging land owners to participate in land management conservation practices that are economically feasible and environmentally responsible.

While this is an on-going effort, the District sent out a questionnaire to 180 individuals, organizations, municipalities, department of defense, and county and state agencies in an effort Importance to identify resource concerns within the District across landowner communities. Responses were received from four cooperators in good standing, one non-governmental organization, USAG- Fort Huachuca, and three state agencies. While the response was timid for the effort exerted, the responses that were received provided a good picture of similar resource concerns across the various land managers.

Identifying the resources of greatest concerns will enable the District to work more effectively with the local NRCS Soil Conservationist when looking for funding to implement individual and land-scale projects.
